Promotion Terms & Conditions.

Authorized under NSW Permit No **LTPS /19/33918**

General

1. The ‘*Where in the world?*’ Trade Promotion is free entry upon the required minimum spend, renewing of membership, taking out new membership and is open to *Club Catalina* Members (including Provisional members), excluding Junior members.
2. Members must be aged 18 years or over.
3. Members must be in possession of their current **Club Catalina** membership card in order to participate.
4. Membership cards must be presented and used for any Point of Sale transactions and through the Member Reward Kiosk to participate in the promotion.
5. Membership card loss or malfunction will result in the member being unable to participate in the promotion. In the case of permanent card loss, a replacement may be obtained from Reception for a fee.
6. Club Catalina Board of Directors, Management, Staff and their respective spouses* who have been associated with the club for any time since the commencement of the promotion, are not eligible to claim any prizes on offer.
7. Contract Caterers of *Club Catalina* are not eligible to claim the prize whilst they are on club premises carrying out their contracted duties.

**Spouse - Definition of word ‘spouse’ in relation to promotions conducted by Club Catalina: Spouse – known couple, whether by marriage or defacto relationship, living under the same roof at any time during the promotion.*

Duration of Promotion

How to Enter

8. Members using their **Club Catalina Membership Card** can receive a ticket and enter the competition in any of these four ways:
1. Presenting their card when making an in-Club purchase over \$10 in one transaction – see clause 9;
 2. Swiping their Club Catalina Membership Card at the in-foyer kiosk – see clause 10;
 3. New to Club member signing up for any membership (Golf or Social) – see clause 11;
 4. Renewal of existing membership to Club Catalina during the promotion period – see clause 12.

9. Members on presentation of their current **Club Catalina Membership Card** at the time of purchase, will receive one (1) FREE entry into the ‘Where in the World?’ Promotion when making a purchase of **\$10 or more** on Food, Beverage and Golf in the following participating departments:

The Point of Sale system will automatically generate a (1) FREE entry ticket on completion of the purchase/sale of **\$10 or more**.

e.g., \$8 = 0 entry; \$10 = 1 entry; \$18 = 1 entry; \$22 = 1 entry etc.

10. Member Reward Kiosk – daily FREE entry/ entries will also be available each day to win through the Member Reward Kiosk located in the foyer of Club Catalina for the duration of the promotion. These tickets are generated and won from the Member Reward Kiosks.

11. New Members will also participate in the promotion by taking up a new Membership 2019/20 during Promotional Period.

 15. The Club will not be held liable for any interruptions to Member Reward Kiosk prize generation or promotions caused by technical failure of the Prize Kiosk.
 16. Manual tickets will be made available to members in the event of prolonged system failure.
 17. Promotion excludes the hiring fees of the Chardonnay, Forum, Clyde and View rooms, e.g. Function and Events.

19. **Members must be financial and present at this venue at the time of the draw to claim prize.**
20. Prize winners will be selected by a manual ticket draw conducted by a nominated Club Catalina Operational Leader who will mix and randomly draw a ticket from the Entry Barrel.
21. Valid entry tickets will be placed back in the barrel once selected.
22. Members must be present in ground floor trading areas of *Club Catalina* at the time of the first announcement of their name over the public address (PA) system to claim the prize.
23. Winning members have four (4) minutes from the first PA announcement of their name, to present themselves with Club Membership identification to the Club representative to claim the prize.
24. Any tickets other than official Club Catalina issued 'Where in the world?' tickets will be considered void.
25. Tickets which are illegible will be considered void.
26. Tickets for members who are suspended, cited to face the Board or deceased, become void upon the aforementioned incidents prior to the time of the draw(s). These events will result in a redraw.
27. In the event a draw is conducted and the drawn membership number is that of an on-duty contractor, Director, Club employee or their respective spouse (excludes spouse of contractor), a redraw will be conducted following notification to members over the PA system.

Draw Times and Prizes

28. Prize determination is as follows:

If an eligible member is drawn out of the barrel for any of the three minor draws and they are present and financial at the draw, they will be provided with one cruise ship voucher via Helloworld Moruya to the value of \$1,500 each.
